## Membership Declaration

As a student of South West Martial Arts, I understand that:

- 1. I may be dismissed at anytime for misconduct or actions which may convey a bad image.
- 2. My monthly training fee is based on a 47 week year. There are no classes for 2 weeks over the Christmas and New Year period. A further 2 weeks are set aside for instructor holidays/training courses but in reality assistant instructors will no doubt be available to cover classes when the chief instructor is away at such times. A further week is set aside for Easter, May and August Public Holidays (Christmas & New Year holidays are accounted for in the Christmas two week closure).
- 3. Refund of fees will not be given in the event of club closures (this is already accounted for meaning you don't actually pay for club closures), sickness or student holiday unless in exceptional circumstances and is agreed between the chief instructor and student/parent.
- 4. Occasionally there may be unforeseen circumstances where the school will be closed without warning, e.g. Instructor illness. These closures have no bearing on the annual 2 week closure mentioned above.
- 5. Every possible opportunity will be made to notify me of sudden cancellations of classes, especially via email and social media, and it is my duty as a student to check those details regularly.
- 6. That as a **parent of a student**, I will **not simply drop my child off in the car park**, but **take them into the training hall**, thereby ensuring that the class is running and preventing the child from being left without proper supervision. I will also collect my child promptly when the lesson has finished.
- 7. I must train on a regular basis in order to be eligible for a grading.
- 8. Grading is a privilege earned by regular training as well as successful improvement in technique and ability. The opportunity to grade is **not** simply a right bought by monthly fees. South West Martial Arts is committed to promoting excellent martial artists and those students who do not fulfill minimum training requirements will not be considered for a grade promotion.
- 9. I will pay my monthly training fees by direct debit.
- 10. I will give one months notice should I decide to stop training and it is my responsibility to cancel the direct debit; should I forget to cancel, no refund will be given.
- 11. I confirm that I am aware that the instructor may withhold training if my membership is not current (renewable annually) and/or training fees are unpaid
- 12. All safety equipment (i.e sparring gloves, boots, helmet etc) must be bought through the Instructor. I understand that any equipment purchased elsewhere will not be allowed.
